The report annexed below shows the income and expenditure to date, as compared to the annual budget.

In addition to the expenditure shown, the Chairman incurred costs of £41.94 on refreshments purchased to toast the award given to Mike Patching earlier this year by the Lord Lieutenant of Oxfordshire, at the village fete. Members are requested to approve the reimbursement of this expenditure.

6) B4100 road closure

Following the meeting on 14 July, there has been further contact with both the contractor working for Thames Water, Murphy Group, and Oxfordshire County Council regarding the sewerage works affecting the B4100. The various issues raised at the meeting on the 14th were put to the contractor and the County Council, and they have both responded.

It appears that the period of complete road closure will now be reduced to between one and two weeks, depending on ground conditions. Also, the official diversion route will now be via the M40, rather than via the Fosse Way. The grass verges through the village and along the B4100 have been cut. It has been agreed that signage will be erected to discourage traffic from using Wroxton Lane, indicating that it is a single track road, and also encouraging lower speeds.

7) Land adjoining the Old Council Houses, Wroxton Lane

As agreed at the meeting on 19 May, a working party was organised to clear the land adjoining the Old Council Houses. Members may now wish to consider whether they wish to put a regular maintenance regime in place, or to organise any works to improve the land such as further landscaping or bulb planting.

8) Verge maintenance

This year Oxfordshire County Council has reduced its grass verge maintenance. Instead of two cuts per year, now only one cut is planned, other than in areas where it is necessary to maintain visibility for road safety. The rural verges in Horley parish were cut in late July, with the verges within the 30 mph limit due to be cut during August.

Previously the Council has declined to enter into a legal agreement with the County Council taking over any of their responsibilities, largely due to the onerous nature of such an agreement from the Parish Council's point of view. However, in view of the reduced standard of service, the Council may wish to review that decision, or alternatively consider undertaking some supplementary works itself next year, without entering into a formal legal agreement. If so, it would be appropriate to investigate the likely costs, so some provision can be made in next year's budget when it is considered in November.
